DEFERRED DISPOSITION UNDER CCP ART. 45.051

On this the **5th day of August, 2021** Defendant entered his/her plea of **NOLO CONTENDERE** to the charge of **HUNT A WILD ANIMAL OR BIRD FROM PUBLIC ROAD**. Defendant requested suspension of sentence and deferral of final disposition of the matter. The Court, having made the determination that Defendant qualifies for deferred disposition, **GRANTS** deferred disposition without entering an adjudication of guilt and places the defendant on probation for a period of **120** days until **12/03/2021**, with conditions; now, therefore it is **ORDERED** that the Defendant:

- (X) Pay/satisfy court costs & a special expense fee in the amount of **\$581.00 by 11/05/2021**.
- (X) Commit no offense against the laws of the State of Texas or any other state, or the laws of the United States of America.

At the end of the deferral period, Defendant is ordered to present satisfactory evidence of compliance with the foregoing requirements, and the complaint will be dismissed without entry of a final conviction. **IF NO SUCH PROOF IS PRESENTED, THE COURT MAY ORDER DEFENDANT TO APPEAR IN COURT TO SHOW CAUSE WHY THE ORDER OF DEFERRAL SHOULD NOT BE REVOKED.**
