ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

There are two small pigs housed in room 182 (id numbers 1091 and 1121) that are in need of hoof trimming. The pigs are in enclosures with floors that are of a vinyl coated mesh with holes large enough that the smaller pigs could get their toes caught in them and become injured. While the pigs are on study the hoof trimming might not be possible until there is a break or resting period, during the lengthy study periods this may result in the hooves overgrowing increasing the risk of injury in these enclosures. There is no plan in place to monitor these animals to ensure that the hoof trimming may be completed in a timely manner. An appropriate means of managing these pigs to allow effective husbandry shall be developed and implemented to ensure that the hoof trimming is not delayed for an extended period of time and to minimize the risk of injury. The pigs hooves shall be trimmed to prevent injury. Correct by August 31, 2015.

FACILITIES, GENERAL.

There are two boxes of cereal and a can of nuts stored on an open shelf in animal room 182. These items are used as treats for the pigs. The boxes of cereal are open and appear to have been exposed to water or humidity, possibly during washdown. Exposure to water and humidity may cause deterioration or contamination of the food. Food shall be stored in a manner that protects them from contamination and deterioration. Correct by August 13, 2015.
