Gaddy introduced herself and explained that she was assigned to the complaint the complainant filed with TDLR in February.</p> <p>-- The complainant verified that she was with the volunteer rescue group in case BRE20220007400 and that she could not add much more than what has already been reported.</p> <p>-- Her main complaint was that the animals were being forced to fight each other, they are underfed and tethered with chains.</p> <p>-- It was explained that TDLR regulates Breeders and in order to be deemed a Breeder one would have to possess 11 or more intact females and sells or exchanges, or offers to sell or exchange, more than 20 animals in a year.</p> <p>-- The complainant interjected, "Yeah, he definitely does not have that many female's."</p> <p>-- She was told that TDLR is looking into the Quiet Boys Kennels in attempt to ascertain if they are considered Breeders under the Occupations Code and that the criminal allegations should be reported to local LE as they were in this case.</p> <p>-- She thanked Inv.
