Nature: Animal Neglect

On May 20, 2020 at about 9:37am I, Deputy Hanneman, was informed by dispatch that Bethanie A. Gengler (F/W DOB 6/9/85) had called and wanted to report animal neglect at the Animal Haven Zoo at N1720 Buchholtz Rd. in the Town of Weyauwega, Waupaca County, Wisconsin. Dispatch then transferred the phone call to my cell phone.

I spoke to Bethanie on the phone and she told me that she had visited the Animal Haven Zoo and was concerned about some of the things going on there. She stated that she observed a donkey that was housed next to a tiger cage and was only separated by the wire on the cage. She stated that in her opinion it was causing the donkey unnecessary stress. She also stated that she observed a bobcat in a cage that had an infected eye. She stated that she witnessed a bear that kept opening and closing it's mouth. She stated that she thought that was a reaction due to pain. She stated that she observed a red fox that laid in it's cage the entire time she was there and didn't move. She stated she didn't know if the fox was alive or not. She told me that she observed a dead bird hanging from a tree on the property. She stated that it appeared that the animals were not being fed properly. Bethanie stated that the parrots did not have any food at all and had empty sunflower seeds in their dishes. She stated that the parrots had plucked their feathers out due to what she thought was stress. She told me that the animals lacked shelter at the property. Bethanie stated that alligators and tortoises were being housed outside and she thought it was too cold for them to be outside. She stated that she observed a tortoise that had a deformed shell due to what she thought was a metabolic bone disease. She stated she observed that there was a marine toad in a dirty 10 gallon aquarium with it's eye clouded over. She stated she thought that was due to a bacterial infection. She stated she observed a large male ostrich that was trying to attack visitors. She stated that she was concerned because there were rabbits, goats, and fowl that were running around free on the property. She stated she observed a porcupine that was pacing due to what she believed a lack of enrichment. She stated that much of the property was flooded leaving no dry areas for the animals to lie down. She informed me that many of the enclosures did not have tops, allowing visitors to access the animals. She stated an employee allowed a bear to lick the employee's face. Bethanie stated that she would send me a detailed email about what she observed as well as send photos and videos. She did send all those emails which I viewed and they are attached to this report. Bethanie also put my work email on a facebook site and I received 1 email from a Landon Boelter, which is attached to this report.

After viewing the email, photos, and videos I called Bethanie back. I explained to her that from her videos and photos it appeared that the animals were not malnourished. I informed her that we could make sure the animals had adequate food, water, shelter, and were not being abused. I told her that something like the donkey being housed next to a tiger is not something we can take enforcement action against. She asked about the rabbits and goats that were running loose. I informed her that our ordinance for animals at large did not apply to animals running on someone's private property. She got upset and stated so you're telling me they can just let their tigers run loose. I informed her that there was a big difference between a tiger being loose and a goat or rabbit. I informed her that I would forward all the information that she gave me to Humane

Deputy Copes.

On May 21, 2020 at about 8:46am I, Deputy Hanneman, along with Deputy Copes arrived at the Animal Haven Zoo. We meet with the owners James P. Hoffenber (M/W DOB 1/20/46) and Dawn L. Hoffenber (F/W DOB 3/11/48). I explained to them the complaint we had received and asked if we could check on the welfare of the animals. They stated they would be glad to show us around and stated we could take as many pictures as we wanted. Dawn stated she was aware that someone was speaking ill of the zoo on facebook. Dawn showed me an inspection report from USDA agent Jessica Rivera from dated July 30, 2019. This report stated no non-compliant items identified during the inspection. She also showed me her USDA class B dealer license. She also showed me a report from Veterinarian Albert Prudom that stated the animals at the zoo were all in good condition. They later provided us a letter from Albert stated "I did a walk through examined all animals at Animal Haven 200. I believe all the animals are healthy + being very adequately cared for."

Dawn and James then took us from cage to cage to look at all the animals in the zoo. While I was doing this I photographed several animals, their shelters, food, and water containers. I observed the bobcat that Bethanie had referenced and Dawn explained that the bobcat had allergies and that is why the eyes was the way it appeared. She stated she did have their vet look at the bobcat. The donkey was no longer housed near the tiger cages. I did not observed any bears that were opening and closing their mouths. I did observe a red fox in a cage that was walking around and appeared in good health. They took us into the bird cages and I observed that they had several dishes with food in them and had adequate water. I did not observe any parrots with abnormal amounts of feathers plucked out. I observed the alligators and tortoises in their enclosures and asked them what they do with them when the temperatures drop at night. She pointed out a shed that she explained was heated and the animals that could not be out in the cold would be moved into the 80 degree shed. Dawn pointed out the tortoise with the deformed shell and stated they had gotten the tortoise that way. They showed me the toad in the aquarium. Dawn stated that she had just cleaned the aquarium and explained the need for water in the aquarium. She explained how that type of toad shed it skin. She stated the eyes looked glossy because it was about to shed its skin. At about this point Dawn had to attended with opening the zoo so James took us the rest of the way around.

James explained that all the animals were fed every day with exception of the lions and tigers. He stated that they were fed about every other day. While walking around the entire zoo I did not see any animals that appeared sick or malnourished. Their water dishes were full and very clean with the exception of a few of the animals that dirtied their own water dishes. I did observe that the zebras did not have any water in their water dishes. The prairie dogs also did not have water in their dishes. While we were walking around I observed a juvenile female employee driving a UTV that had several pales of water in the back. She stated she was watering and feeding the animals. She stated that the animals are fed and watered every day. She stated that the Zebras were given water the previous day. I did observe some wet areas in the zoo, but there appeared to always be a dry spot in the enclosures for the animals to be. I also observed that every animal enclosure had some sort of shelter for the animals. James explained to me why he had to have wiring on the top of some of the cages and explained to me how he provided shaded areas for the animals.

James took us to where the male ostrich was and I observed that there was a

nylon strap that was preventing people from getting close to the enclosure. He told me that a few days prior he had removed the strap because the Amish were trimming the hooves of animals in the enclosure next to the ostrich. James acknowledged that he should have not removed the strap, but that no one reported being attacked by the ostrich. I observed the porcupine that Bethanie had sent a video on. The porcupine was laying in its shelter and appeared in good health. James and Dawn were very accommodating for us to investigate the complaint. They both explained that they had a passion for rescuing the animals and enjoyed children being able to view them.

While still at the zoo Veterinarian Albert called James and I spoke to him on the phone. He told me that he had inspected the animals and they were all in good health, cared for, and he did not have any issues with the care of the animals. He stated that on average he was at the zoo about once per month, but sometimes more. I contacted USDA agent Jessica Rivera on the phone and informed her about the complaint and my findings at the zoo. She confirmed that during the last inspection at the zoo there were no non-compliant issues. She thanked me for the information and stated she would contact me if she needed anything further. At this time Humane Deputy Copes and I did not see any issues on the property that required law enforcement action from the Sheriff's Department.

On May 21, at approximately 845sm, I, Humane Officer, Deputy Craig Copes, along with Deputy Paul Hannamen, went to Animal Haven Zoo, N1720 Bucholtz Road, Weyauwega, because of an Animal Neglect Complaint.

Owner James Hoffenber, DOB 01-20-46, took us to each animal/enclosure in the zoo. All enclosures seemed adequate. All animals seemed well taken care off. All with couple exceptions had clean water. The zebras were out of water, but we were told they drink it as soon as it's given. Each animal is given food and fresh water every day, with the couple exceptions. The lions and tigers are fed every other day. We were also told the USDA and a local vet do periodic checks. Recent checks found no problems. Last USDA check was 2019, the 2020 visit was postponed due to COVID19 issues. The veterinarian visit was on same day as our visit. No abuse or neglect of the animals was observed.

INTRODUCTION -

On 5/31/2020 at approximately 4:17 PM, I, Deputy Justin Malueg Badge #545, with the Waupaca County Sheriff's Office, while in full uniform operating a fully marked squad car, was dispatched to an animal neglect complaint located at N1720 Bucholtz Road (Animal Haven Zoo), Township of Weyauwega, Waupaca County, Wisconsin. I was currently field training with Deputy Much, Badge #546, at the time of this incident.

It was reported by Angela K. Vanpatten (F/U, DOB of 9/17/1967) the following:

"BROWN OR BLACK BEAR WAS SITTING IN ITS OWN URINE. HYENA PACING BACK AND FORTH. PENS ARE NASTY, FULL OF FECES AND MUD. MONKEY'S REAR IS RED, POOP HANGING."

ARRIVAL ON SCENE -

I arrived on scene and spoke with the owners of the zoo, identified as Dawn L. Hofferber (F/W, DOB of 3/11/1948) and James P. Hofferber (M/W, DOB of 1/20/1946). After informing Dawn and James of the complaint, Dawn stated she had an upset customer at the zoo yesterday that complained to her of the same thing. She said that it was a female individual who was very loud and disruptive about the complaint. She said there were two other families present while this female became disruptive. She said after this female had left, one of the families came up to her and complimented her on how she handled the situation with that female. She said this family had also complimented her on how she has been running her zoo.

Dawn also explained to me that the bear was wet from water yesterday, not from its urine. She explained that bears urinate while they walk, not while they are seated. She explained that the monkeys usually have a red buttocks, especially while they are in heat. She explained that the hyenas usually pace back and forth.

ZOO WALK THROUGH -

James and Dawn both offered for us to enter the zoo property to investigate and take photographs. We walked through part of the zoo and didn't locate or observe anything that seemed out of the ordinary. All of the animals that we saw had food, water and shelter. All of the pens appeared to be clean and free of excessive feces.

The bears, monkeys and hyena all appeared to look healthy and had clean food, water and shelter. As we walked up to the hyena, it was lying down and resting. As we approached closer, it stood up and started pacing. This would be consistent with what Dawn had explained to us.

We took photographs of each of the animals in question per the complaint.

CONCLUSION -

Overall, we did not observe anything that seemed concerning in regards to the animals. While we were there today, there were numerous families present and enjoying themselves with the animals. We did not have any of these families approach us with any concerns.

I forwarded this information to Deputy Besel and Deputy Copes for their records, as they are the County Humane Officers.

I have nothing further at this time.

The bob cat has an eye allergy and is treated weekly. The toads eyes seemed normal. The coyotes both seemed very normal, with no leg issues. The goats had no hoof problems.

Pictures of each animal were taken by Deputy Kriegel. It should also be noted the Zoo's Veterinarian comes once a month and checks on each animal.

INITIAL INFORMATION:

On August 26, 2021, I, Deputy Alec Brockman #537, was working a scheduled shift for the Waupaca County Sheriff's Office in full duty uniform and operating a marked patrol vehicle (2018 Ford Explorer, gray in color, blue lettering).

At approximately 12:50 P.M., The Waupaca County Communications Center (hereinafter referred to as Comm. Center) called out via radio advising me of an animal problem complaint at the address of N1720 Buchholtz Road (Animal Haven Zoo) located in the Township of Weyauwega, Waupaca County, Wisconsin 54983.

The Comm. Center received an anonymous complaint of rabbits with the appearance of sickness at the Animal Haven Zoo. It was requested the welfare of the animals be assessed. I responded to complaint from the Manawa area. Deputy C. Copes #573, also responded to assist as he specializes in situations related to animal humanity.

ARRIVAL ON SCENE:

Deputy Copes and I arrived at approximately 1:37 P.M. We made contact with staff at the front reception area and were invited to walk-thru the property. We responded to several rabbit enclosures to assess their well-being.

CONDITION OF ANIMALS:

There were numerous rabbits in the enclosure. One had a rash-like concentration on it's nose, most were laying down, there was access to food, water, shade, and several flies were hovering near the enclosure.

CONTACT WITH ZOO OWNER AND USDA:

We made contact with the owner of the zoo and confirmed his identity verbally as Jim Hofferber (M/W DOB: 01/20/1946). Also present with Jim were two agents from the USDA. Deputy Copes explained the nature of our concerns to Jim and the agents. Jim advised one rabbit was removed from the enclosure due to its health. The removed rabbit was younger and possibly had an infection. Two additional rabbits were going to be receiving veterinary care. The rabbits were recently acquired from Paul's Auction Service. Agents from the USDA added the cleanliness of the enclosures needed to be improved. We thanked all parties for their information and concluded our contact.

ADDITIOANL INFORMATION:

As we were exiting the zoo we made contact with Brenda Aeschbach. Brenda was a Supervisory Investigator with the United States Department of Agriculture. Brenda was investigating an unrelated incident regarding public exposure of a youth tiger. Brenda was apprised of the nature of our investigation and given our contact information. We concluded our contact with her and departed from the property. No other concerning circumstances were observed during our walk-thru

of the zoo.
