

COMPLAINT

CASE NUMBER: **21GG0072**

The CHRB hereby files a complaint against **Jacqui M. Navarre** for violation of CHRB Rule **1843(a)&(d), 1843.1(b), 1844(d)(3), 1842.5 and 1887(a)**. The person named in this complaint holds a license as a **Trainer**, license number **324738-02/2024**. The offense alleged occurred on or about **10/30/2021** and is as follows:

The official blood sample #GG39230 taken at Golden Gate Fields from horse Code Ribbon was reported by Dr. Ben Moeller, PhD of UC Davis Laboratory, to contain 74.8 ug/ML of Dimethylsulfoxide (DMSO). The sample was obtained from the horse after it ran in race #7 at Golden Gate Fields, finishing 3rd. The trainer of record was Jacqui Navarre. DMSO in a horse's system at the time of testing is a Drug Class 4, Penalty Class C violation.

A split-sample was requested with Texas Veterinary Medical Diagnostic Laboratory confirming the presence of DMSO in the horse's system. During the investigation, it was discovered that Trainer Navarre did not maintain any medication treatment records. Trainer Navarre does not have a history of prior medication positive violation.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
