Dear Sheriff Cook or Custodian of Records for the Clay County Sheriff:

Pursuant to Article I, section 24 of the Florida Constitution, and chapter 119, F.S., I am requesting an opportunity to inspect or obtain copies of public records that relate to licensed exhibitors operating for commercial gain within your state who may be in violation of state and federal animal welfare and cruelty laws.

In particular, I am requesting copies of:

*Any documentation related to possible animal care violations filed with your office – including but not limited to complaints, inspection reports, investigative findings, photographs, emailed or written correspondence – regarding Single Vision, with address at 8185 Forest Hills Rd in Melrose, from Jan. 1, 2018 through date of processing this request.

I would like to receive these files electronically if possible.

Please let me know if the anticipated costs will exceed \$25. In order to help to determine my status to assess fees, you should know that I am a representative of the news media affiliated with the nonprofit news outlet Lady Freethinker, and this request is made as part of news gathering and not for a commercial use.

I request a waiver of all fees for this request. Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of whether this facility is in compliance with state animal welfare laws and your agency's oversight of said facility to that end. Disclosure of this information is not primarily in my commercial interest.

Please provide expedited processing of this request, which concerns a matter of urgency. As a reporter, I am primarily engaged in disseminating information. The public has an urgent need for information about this roadside attraction as they recently were cited by the U.S. Department of Agriculture for having noncompliance with the AWA. I certify that my statements concerning the need for expedited processing are true and correct to the best of my knowledge and belief.

On 05-05-2018 at 0945 hours, I was dispatched to an animal bite investigation that occurred at 8185 Forest Hills Road, the business of Single Vision.

I was advised by dispatch the victim, Carl Bovard, is currently at the Putnam County Hospital.

I made phone contact with the victim and he advised the following: He is a lion trainer and owns Single Vision and he has several wild mountain lions and tigers. Around 0800 hours this morning he was cleaning out the age for one of the mountain lions named Mayhem. The mountain lion became frisky and started biting and scratching him. He was bit on his arms and was scratched on the back of his head. He was able to push the mountain lion off him and safely exit the cage. He advised he has to have several stiches to the back of his head and arms.

Dispatch contacted Florida Fish and Game of the incident and they advised will be responding.
