

COMPLAINT

CASE NUMBER: 20DM0069

The CHRB hereby files a complaint against **RONALD MCANALLY, DEBORAH MCANALLY, and GEOVANNI FRANCO** for violation of CHRB Rule **1859.5**. The person named in this complaint holds a license as a **TRAINER, OWNER, and JOCKEY**, license number **071630-07/2023, 208158-05/2021, and 304141-01/2023**. The offense alleged occurred on or about **11/22/2020** and is as follows:

The official urine sample #DM16675 taken on 11/22/2020 at Del Mar was reported by Dr. BEN MOELLER of UC Davis Laboratories to contain 7-Carboxy-Cannabidiol, a metabolite of cannabidiol. The sample was obtained from the horse ROSES AND CANDY which ran in the 3rd race at Del Mar finishing 1st. The trainer of record is RONALD MCANALLY. A requested split sample confirmed the finding of 7-Carboxy-Cannabidiol. The violation is a class 1 drug with a penalty category A. The owner of ROSES AND CANDY is DEBORAH MCANALLY. The jockey during the race was GEOVANNI FRANCO. Per rule 1859.5 the horse shall be disqualified and any purse money forfeited.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
