1843.1(a), & 1887. The person named in this complaint holds a license as a Trainer, license number -248320 -

06/2022. The offense alleged occurred on or about 11/6/2020 and

is as follows:

Official urine sample #LA47318 taken on 11/6/2020 at LARC from horse, "Fames Fire" was reported by Ben Moeller, PhD of the Maddy EACL at UC Davis contained Phenylbutazone and Flunixin. Phenylbutazone is a prohibited drug substance, class 4, penalty class C. Flunixin is a prohibited drug substance, class 4, penalty class C. The horse, "Fames Fire" which ran in the 6th race finishing 1^{st.} The split analysis was not requested in accordance to 1859.25. Scott Willoughby is the trainer of record.

Pursuant to Business and Professions Code Section 19420, 19440, and CHRB Rules, the stewards are empowered to impose penalties for violation of any provision of the CHRB Rules. Such penalties may consist of suspension of any license, fines, and exclusion from all racing enclosures under the jurisdiction of the Board or by any combination of these penalties.
